**Position Description:** Leadership Education in Neurodevelopmental and Related Disabilities (LEND) programs provide long-term, graduate level interdisciplinary training as well as interdisciplinary services and care. The purpose of the LEND training program is to improve the health of infants, children, and adolescents with disabilities. This is accomplished by preparing trainees from diverse professional disciplines to assume leadership roles in their respective fields and by insuring high levels of interdisciplinary clinical competence. LEND is funded through a grant from the federal Maternal and Child Health Bureau. Position availability is subject to yearly grant funding. All trainees will participate in the following activities: attend LEND Next Steps and Feeding Clinics; attend Journal Club and Leadership Seminar; participate in Family Partnership Program; complete clinical and community observations; complete the courses *Disabilities and the Family* and *Life Span Disability Policy or Disability and Society* and receive mentoring.
